Directions: This form must be accompanied by \$5.00 for each ID ordered. Checks must be made payable to **CAM**, and mailed to 9802 F.M. 1960 Bypass W., #210, Humble, TX 77338. You will receive your pool ID(s) by mail before the swim season begins. The Board of Trustees of the Atascocita South C.I.A. has specified that: (1) failure of a swimmer to follow the posted rules will result in revocation of pool IDs; and (2) the IDs must be worn at all times when the ID holder is inside the pool fence.

During most hours when the pool is closed to the public, the pool may be rented by members of the Association for private parties (advance payment for lifeguards and deposit is required).

About the Pool ID Distribution Process

Dear Residents,

As you may recall, pool IDs are annually renewing, available to Atascocita South residents who wish to use the community pool. The pool ID fee is separate from your annual assessment.

Pool IDs are scheduled to be sold at the pool from 12 pm to 2 pm on Saturday, May 4, 2019 and Saturday, May 11, 2019 from 12 pm to 2 pm. Pool IDs may also be obtained from the Association's office Monday-Friday from 8:30-5:30 pm.

Using the pool ID form printed on the reverse side of this message, you may order your IDs by mail, and the IDs will be mailed to you. You may also pick up your IDs in the Association's office, 9802 F.M. 1960 Bypass W., Ste. 210, Humble, TX 77338, 8:30 a.m. to 5:30 p.m., Monday through Friday. They will not be available for purchase evenings, weekends or holidays.

There will be a Community Picnic from 12 – 2pm on Saturday, May 4th, 2019 at the pavilion.

For the 2019 Swim Season, the pool will be open (1) weekends in May, Sat. 10am to 9pm, and Sun. 1pm to 7pm, and Memorial Day 10am to 9pm; (2) Swim Season (when school is not in session), Sun. 1pm to 9pm, Mon. 5pm to 9 pm, and Tues. through Sat. 10am to 9 pm; and (3) after school resumes, the pool will open on Labor Day, 10am-9pm, then weekends only, Friday, 5 pm to 9 pm, Saturday 10 am to 9 pm and Sunday 1 pm to 9 pm.

Visitors' passes will be available for sale at the pool entrance at a cost of \$5.00 per day. Visitors' passes will be sold for cash only, with no change made, and no checks accepted. All visitors must be accompanied by a tag-holder member of the Association.

The Board is confident that if all owners follow these guidelines, it will be easy for all to begin enjoying Atascocita South's beautiful facilities again this swim season.
